Cooperative courses.

Cooperative courses may be certified if your school is accredited and conforms to the criteria outlined in 38 CFR 21.4233(a). Credit hours must be properly identified on the student's Enrollment Certification VA Form 22-1999. Your school must be able to document that these courses meet the requirements of the law.

Independent study.

Courses may be certified for independent study if your school is accredited and conforms to the criteria outlined in 38 CFR 21.4267(b). These courses must be listed in your college catalog, are an integral part of the student's program and credit earned apply to the student's degree objective. Credit hours must be properly identified on the student's Enrollment Certification VA Form 22-1999. Your school must be able to document that these courses meet the requirements of the law.
